First, the Court considered the state supreme court's decision as applied to the question of whether a criminal defendant should be allowed to present evidence of a collateral crime to support a theory of self-defense. this question began with the observation that "a state rule limiting admissible evidence, either to relevant or irrelevant material, is 'not a federal constitutional rule." Id. at 64, 105 S.Ct. at 1077. This statement must be read in light of the Supreme Court's previous holding in Davis v. Alaska, 415 U.S. 308, 316-17, 94 S.Ct. 1105, 1110, 39
